## 1. General Provisions

---

These Terms of Use (hereinafter “Terms”) govern the use of the website accessible at <https://www.bakery.vc> (hereinafter “Website”), operated by Bakery Ventures sp. z o.o., a company incorporated under the laws of the Republic of Poland, entered in the National Court Register (KRS) maintained by the District Court for the capital city of Warsaw (hereinafter “Operator”).

These Terms constitute regulations for the provision of electronic services within the meaning of Article 8 of the Polish Act of 18 July 2002 on the Provision of Electronic Services (ustawa o świadczeniu usług drogą elektroniczną, hereinafter “Electronic Services Act”).

By accessing or using the Website, you acknowledge that you have read, understood and agree to be bound by these Terms. If you do not agree to these Terms, you must not use the Website.

## 2. Definitions

---

- “User” means any natural person, legal person or organisational unit without legal personality who accesses or uses the Website.
- “Website” means the internet service available at <https://www.bakery.vc> and all its sub-pages.
- “Operator” means Bakery Ventures sp. z o.o.
- “Content” means all text, graphics, logos, images, data, software and other materials available on the Website.
- “Services” means the electronic services provided through the Website, as described in Section 4.

## 3. Technical Requirements

---

In order to use the Website, the User must have:

- A device with internet access (computer, tablet, smartphone)
- A web browser supporting current web standards (e.g. Google Chrome, Mozilla Firefox, Safari, Microsoft Edge — latest or previous version)
- JavaScript enabled
- Cookies enabled (for full functionality)

The Operator does not guarantee that the Website will function correctly on all devices, browsers or operating systems.

## 4. Services Provided via the Website

---

The Website provides the following electronic services:

- a) Informational content: presentation of information about Bakery Ventures, its investment strategy, portfolio, team and activities in the venture capital and startup ecosystem.
- b) Contact functionality: the ability to send enquiries via contact forms or direct e-mail.
- c) Newsletter: periodic distribution of information about Bakery Ventures activities, events and industry insights (upon subscription with consent).
- d) Redirection: links to the MESGA.eu platform for acceleration and matchmaking services.

The services listed above are provided free of charge unless otherwise expressly stated.

## 5. User Obligations

---

The User agrees to use the Website in accordance with applicable law, these Terms, good customs (dobre obyczaje) and the general principles of internet usage. In particular, the User shall not:

- Use the Website in a manner that disrupts its operation or interferes with other Users' access
- Attempt to gain unauthorised access to any part of the Website, its servers, databases or connected networks

- Use automated tools, bots, scrapers or similar technologies to access, collect or extract data from the Website without the prior written consent of the Operator
- Transmit any content that is unlawful, defamatory, obscene, threatening, harmful or that violates the rights of third parties
- Use the Website to distribute unsolicited commercial communications (spam)
- Impersonate any person or entity, or misrepresent your affiliation with any person or entity
- Attempt to reverse-engineer, decompile or disassemble any part of the Website's software

## 6. Intellectual Property

---

All Content available on the Website, including but not limited to text, graphics, logos, trademarks, trade names, images, audio and video materials, data compilations and software, is the property of the Operator or its licensors and is protected by Polish and international intellectual property laws, including the Polish Act of 4 February 1994 on Copyright and Related Rights (ustawa o prawie autorskim i prawach pokrewnych) and the Polish Industrial Property Act of 30 June 2000 (Prawo własności przemysłowej).

Users may view and download Content solely for personal, non-commercial use. Any reproduction, distribution, modification, public display or commercial exploitation of the Content without the prior written consent of the Operator is strictly prohibited.

The names "Bakery Ventures", "Bakery.vc", "MESGA" and associated logos are registered trademarks or trade names of the Operator. Unauthorised use of these marks is prohibited.

## 7. Disclaimers

---

### 7.1. No investment advice

The Content on the Website is provided for informational purposes only and does not constitute investment advice, financial advice, legal advice, or a recommendation to buy, sell or hold any securities or financial instruments. Any investment decisions should be made after independent evaluation and consultation with qualified professional advisors.

Past performance of portfolio companies or investments is not indicative of future results. Venture capital investments carry inherent risks, including the risk of total loss of invested capital.

### 7.2. No warranties

The Website and its Content are provided "as is" and "as available" without any warranties, express or implied, to the fullest extent permitted by applicable law. The Operator does not warrant that:

- The Website will be available at all times without interruption or error
- The Content is complete, accurate, up-to-date or reliable
- The Website is free from viruses or other harmful components

To the extent permitted by law, the Operator disclaims all warranties, including implied warranties of merchantability, fitness for a particular purpose and non-infringement.

## 8. Limitation of Liability

---

To the maximum extent permitted by applicable law, the Operator shall not be liable for any direct, indirect, incidental, special, consequential or exemplary damages arising from or in connection with:

- The use of or inability to use the Website
- Any errors, omissions or inaccuracies in the Content
- Any unauthorised access to or alteration of your data
- Any third-party content, products or services accessed through the Website

Nothing in these Terms shall exclude or limit the Operator's liability where such exclusion or limitation would be contrary to mandatory provisions of Polish or EU law, in particular consumer protection legislation.

## 9. Links to Third-Party Websites

---

The Website may contain links to third-party websites, including the MESGA.eu platform. These links are provided for convenience only. The Operator does not endorse, control or assume responsibility for the content, privacy policies or practices of any third-party websites. Access to linked websites is at the User's own risk.

## 10. Complaint Procedure

---

Users may submit complaints regarding the functioning of the Website or the Services by sending a message to: support@bakery.vc.

A complaint should include:

- The User's name or identifier
- A description of the issue, including the date and circumstances of its occurrence
- The User's expectations regarding the resolution

The Operator shall respond to the complaint within 14 days of receipt. If the complaint requires additional investigation, the Operator will inform the User of the expected timeline.

## 11. Termination of Services

---

The User may cease using the Website at any time without notice. Where the User has subscribed to a newsletter, unsubscription constitutes termination of that particular service.

The Operator reserves the right to restrict or terminate access to the Website or its Services for Users who violate these Terms, without prejudice to any claims for damages.

## 12. Modifications to these Terms

---

The Operator reserves the right to amend these Terms at any time. Modified Terms will be published on the Website with a new "Effective date". Material changes will be communicated to Users through a notice on the Website.

Continued use of the Website after the publication of modified Terms constitutes acceptance of those modifications. If the User does not agree with the modified Terms, the User should cease using the Website.

## 13. Governing Law and Jurisdiction

---

These Terms are governed by and construed in accordance with the laws of the Republic of Poland and the European Union.

Any disputes arising from or in connection with these Terms shall be resolved by the competent court with jurisdiction over the registered seat of the Operator, unless mandatory provisions of law (in particular, consumer protection laws) provide otherwise.

In accordance with Regulation (EU) No 524/2013, consumers may also use the European Online Dispute Resolution (ODR) platform, accessible at: <https://ec.europa.eu/consumers/odr>.

## 14. Consumer Rights

---

Nothing in these Terms shall limit or exclude the rights of consumers under the Polish Act of 30 May 2014 on Consumer Rights (ustawa o prawach konsumenta) or other mandatory consumer protection legislation.

Where a User qualifies as a consumer within the meaning of Article 22<sup>1</sup> of the Polish Civil Code, mandatory consumer protection provisions shall take precedence over any conflicting provisions of these Terms.

## 15. Severability

---

If any provision of these Terms is found to be invalid or unenforceable by a court of competent jurisdiction, the remaining provisions shall continue in full force and effect. The invalid or unenforceable provision shall be replaced by a valid provision that most closely reflects the original intent.
